

1. The carrier for all parcels accepted in Flash Pack & ship, hereafter referred to as FPS shall be hereafter referred to as carrier. Parcels accepted by FPS, from customer, hereafter referred to as shipper, are subject to refusal for shipment by the carrier.
2. FPS shall act as agent only for the above receipt and forwarding of parcel (s) by the shipper, whose name and address appear above. FPS assumes no liability for the successful completion of delivery of the parcel (s) accepted for shipment nor for the loss or damage caused by the carrier to the parcel (s) or contents thereof. In the event of loss or damage to said parcel (s), FPS will act as agent on behalf of the shipper for filing and processing of claims. It is hereby expressly agreed that FPS shall have no liability of parcel (s) packed by the shipper, if any claim is denied or paid only in part by the carrier.
3. It is also agreed, that provided the shipper has indicated the "declared value" and paid the appropriate fees, the carrier liability is limited to the repair or replacement value of lost or damaged items of readily ascertainable market value, not to include items of sentimental value. If parcel (s) should arrive damaged, the receiver must arrange for inspection of the parcel (s) with the carriers local agent.
4. Shipper shall not hold FPS liable for failure to make timely delivery date specified. Any statement by FPS as to probable date of delivery by carrier is a statement of opinion only, and shall not be warranted in any manner. FPS shall not be liable for any delays in shipments or deliveries by FPS and/or carrier.
5. The foregoing constitutes the full and complete agreement between FPS and shipper, and supersedes all prior/subsequent representations either written or oral.
6. In the event of a question about this shipment, **DO NOT contact the carrier. Please call FPS. Retain all items, including carton & packing materials. DON NOT RESHIP.** We will act as your agent in filing any claims with the carrier and will rely on the carrier's investigation to determine any compensation due. Purchase of insurance will not guarantee payment of that amount unless verification of the value is made by the customer.

All claims inquiries must be made with 15 days.
